

Image Condition and Use Policy

All rights and reproduction requests must be made in writing. All fees must be paid in advance and an agreement must be signed stating compliance with all rules and conditions for use as required by the Daum Museum of Contemporary Art.

The Daum Museum of Contemporary Art does not lend original photographic material.

A complete fee schedule is available upon request or has already been provided.

The Daum Museum of Contemporary Art makes no warranties or representations and assumes no responsibility whatsoever for any claims against applicant or museum by artists, their agents, estates, or by any parties in connection with the reproduction of works of art in the collections of the museum. The applicant agrees to indemnify the Daum Museum and hold it harmless against any and all such claims, including copyright infringement claims, royalty or fee demands and/or actions, including the costs thereof, arising as a result of the applicant's reproduction of the works of art in the Daum Museum's collections. Any and all royalty payments or other requirements specified by the copyright owner of such work must be paid or honored by the publisher or agent requesting reproduction permission.

Conditions for Use of Still Images

Reproduction rights are granted on a non-exclusive basis only for one usage in one edition of one North American publication, and in one language. Permission to publish in subsequent editions or reprints must be approved in advance and is subject to additional fees. Special permission must be granted for world rights and additional languages.

Reproductions of all images must be captioned with the appropriate credit line of each image, which will be provided by the Registrar, and the following language must immediately follow: **Courtesy of Daum Museum of Contemporary Art.**

Users of materials from Daum Museum of Contemporary Art will be responsible for locating and identifying underlying rights for publication. In some cases this may include contacting organizations such as VAGA, ARS, or the artist or artist's estate if the Daum Museum does not have copyrights.

All fees are payable in advance. Permission for use is contingent upon payment of publication fees in advance of the publication date. The Daum Museum must see the proposed layout and proof(s), color or black and white, before reproduction is approved

Use of images will not be reproduced for anything other than the use approved. Permission for use is contingent upon signature and receipt of the usage contract before the release date of the publication.

All reproductions must be made from photographic materials supplied by the Daum Museum, which remain property of the museum.

Material may not be cropped, retouched, colored, manipulated, used as part of a collage or otherwise altered without the explicit permission of the Daum Museum of Contemporary Art or the copyright holder.

Two copies of the publication or a tear sheet must be provided to the **Daum Museum of Contemporary Art.**

Conditions for Use of Moving Images

Reproductions of all moving images must be captioned with the appropriate credit line of each piece of footage, which will be provided by the Registrar, and the following language must immediately follow: **Courtesy of Daum Museum of Contemporary Art.**

If footage cannot be captioned, then the correct title and following credit must be included at the end of the film and must roll at normal reading speed: **Daum Museum of Contemporary Art**

User of materials will be responsible for locating and identifying underlying rights.

One copy in DVD format of any video or motion picture product made with Daum Museum of Contemporary Art footage must be deposited with the Daum Museum of Contemporary Art upon public release of the product.

Permission for use is contingent upon full payment of use fees before the date on which the video or motion picture is presented for public viewing or broadcast.
